FROM the NOMINATING/ELECTIONS COMMITTEE

Our By-Laws allow for a Board with a minimum of 5 & maximum of 7 Directors. We currently have a 7 member Board. Board members may hold two 2-year consecutive terms, for a total of 4 years. After that they must wait 2 years before requesting to run again.

As per our By-Laws elections will be the 3rd Monday in January, which is January 20, 2020.

After the last announcement was made, our Board Secretary Linda Cammallere had to step down for health reasons. That leaves five remaining members for 2020. As of this writing we have not had anyone stepping forward to serve on our Board. We have five members who will be continuing on and although we can have a Board with just 5 members it will mean that 4 of the 5 will have to become officers. It will also impact on the ability to maintain a quorum for all Directors and HOA meetings. Our Board will function much more efficiently if we have two more members.

In order to run for the Board one has to be a bona fide resident which means their name must appear on the manufactured home registration.

All new Board members are mandated to go to a training session within 90 days of taking office, as per Florida Statutes. As of this writing we do not know when or where a local training session will take place. Our HOA does pay the registration fee. The FMO is looking into on-line training and hopefully that will be in place and another option to meet the mandate. The HOA does not decide on who will be President, V.Pres, Secretary or Treasurer. That takes place at the organizational meeting where the Directors decide amongst themselves who will hold those positions.

Monday, December 2nd is our next HOA meeting and the last date that someone can be nominated to be on the board. We will need a minimum of two people. They must be present at the meeting to accept the nomination. It is important to understand that without an HOA Board, Park Owners have no obliga-

Why Join the FMO?

FMO stands for Federation of Manufactured Home Owners of Florida, Inc. Membership dues to the FMO enable us, as mobile home owners, to afford a paid lobbyist who works to make sure that our rights are being protected from Park Owners. Park Owners have their own association, with several paid lobbyists who work to get bills passed in the Florida Legislature to their benefit, not ours! Their organization, FMHA, has filed a terrible anti-homeowner bill (Senate Bill 818). It is through our FMO that we are informed and asked to mobilize against bills such as this one. In this Ripples is an FMO membership form. Membership provides a monthly Newsletter with valuable information. Go to their Website WWW.FMO.ORG to find out more. If you want to protect the lifestyle you've chosen by living in a mobile home park, then it is extremely important that you join and keep up your membership in FMO.
